

# CALL FOR NOMINATIONS FOR MATĀWAKA REPRESENTATIVES TO THE INDEPENDENT MĀORI STATUTORY BOARD (2022-2025)

## HE KARANGA MŌ ĒTAHI HUNGA TOHU MŌ TE INDEPENDENT MĀORI STATUTORY BOARD (2022-2025)

### Views of Matāwaka are also sought

The Local Government (Auckland Council) Act 2009 established the Independent Māori Statutory Board (IMSB). Its purpose is to promote issues of significance for Mana Whenua groups and Matāwaka in Tāmaki Makaurau.

The IMSB comprises seven Mana Whenua group representatives and two Matāwaka representatives, each serving a term of three years. The members are appointed by a Mana Whenua Selection Body established by the Minister for Māori Development.

#### This notice:

- Outlines the criteria, attributes and process for selection of the two Matāwaka representatives;
- Seeks nominations for the Matāwaka representatives to the IMSB as well as views of Matāwaka for the selection of Matāwaka representatives;

Matāwaka is defined in the Act as Māori living in the Auckland region who are not in a Mana Whenua group.

#### Criteria and attributes of Matāwaka representatives

The Matāwaka representatives are not restricted to people who are Matāwaka but must have the ability to represent and promote issues of significance for Matāwaka. The nomination form includes the option of including documentation such as a CV, statement of attributes, and/or any additional information on the views of Matāwaka on the nomination.

The Act also sets out minimum eligibility criteria for nominees, which are detailed in the nomination form.

Other matters to be considered by the Selection Body include the need for a balance of knowledge and expertise of the following across the whole IMSB:

- Knowledge and expertise in te reo, tikanga, mātauranga;
- Knowledge of the geographic and socio-political makeup of the whole of Tāmaki Makaurau area;
- Knowledge and expertise in areas relevant to local government (eg, resource management, public policy, planning, transport, finance, etc);
- Strong networks and established relationships within Mana Whenua and local and central government spheres;
- Acknowledged as leaders within their own community.

#### Process for seeking nominations and views for selection of Matāwaka representatives

The Selection Body is calling for nominations for the two Matāwaka representatives.

**Nominees must complete the nomination form with required supporting information and ensure it is received no later than 5pm, 7 October 2022.**

The Selection Body will also take into account the views of Matāwaka in relation to the selection of Matāwaka representatives. The views of Matāwaka must be provided in writing to the address below by 5pm, 7 October 2022. No specific form is necessary for this information but it must outline the writer's Matāwaka affiliations.

#### He karanga mō ētahi hunga tohu mō te kāhui māori motuhake ā-ture

#### Ka whāia anō hoki ngā aronga a ngā Matāwaka

Nā te Ture Kāwana-ā-Rohe (Te Kaunihera o Tāmaki Makaurau) 2009 (te Ture) i tohu te Kāhui Māori Motuhake ā-Ture. Ko tōna whāinga ko te

hāpai i ngā tini kaupapa whai patanga ki ngā rōpū Mana Whenua Matāwaka hoki o Tāmaki Makaurau.

Tokowhiti ngā hunga tohu mai i ngā Mana Whenua, tokorua atu mai i ngā Matāwaka ka noho mō ngā tau e toru ki runga i te Kāhui Māori Motuhake ā-Ture. Ko ngā hunga tono ka tohua e tētahi Ohu Whiriwhiri kua tohua kē e te Minita mō ngā Take Whanake Māori.

#### Ko te pūtake o tēnei pānui he:

- Whakaatu i ngā paeuru, i ngā huanga me te raupapa mahi mō ngā hunga tohu mai i ngā Matāwaka;
- Karanga mō ngā tono tūranga Matāwaka ki te Kāhui Māori Motuhake ā-Ture me ngā aronga o te hunga kei roto i te karangatanga Matāwaka hei tohu i aua tūranga e rua;
- Kua tohua e te Ture ko te hunga Matāwaka ko ngai Māori e noho ana ki Tāmaki ki waho kē mai ki ngā uri o ngā rōpū Mana Whenua.

#### Paeuru me ngā huanga o ngā hunga tohu Matāwaka

Ko ngā hunga tohu mō ngā Matāwaka kāhore i tohua mārika mai i ngā rōpū Matāwaka erangi ko te hunga kē ka whai mai o rātou ake pūkenga ki te kawe ki te taki mārika i ngā take whai patanga mō ngā Matāwaka. Kei roto i te puka tapatanga e rārangi ana ngā paeuru tūturu tae atu ki ngā wāhanga ka whāia pērā i ngā rōpū Matāwaka, ngā iwi, ngā rōpū atu e whai pānga ana rātou tae atu ki ngā hononga tautoko mai i ngā Matāwaka.

E horahia ana hoki e te Ture ngā paeuru urunga mō ngā hunga tapatanga ā, kei roto hoki i te puka tapatanga.

Ko ētahi atu wāhanga tērā pea ka arohia e te Ohu Whiriwhiri ko te whai kia hora ki te katoa o ngā hunga o te Kāhui Māori Motuhake ā-Ture te mātauranga me ngā pūkenga mō ngā take e rārangi iho nei:

- Te mātauranga me ngā pūkenga ki te reo, ngā tikanga me ngā momo mātauranga o ngāi Māori whānui o Mana Whenua mārika ake hoki;
- Te mātauranga ki te rohe whenua tae atu ki te momo o te āhuatanga-ā-iwi o te rohe katoa o Tāmaki Makaurau;
- Ko te mātauranga mō, me te tohungatanga ki ngā momo wāhanga o te kāwana-ā-rohe: hei tauira ake, whakahaere taiao, kaupapa here matawhānui, whakatakoto kaupapa, nekenekenga waka, pūtea;
- Ngā hononga whai kiko ki ngā Mana Whenua ki ngā wāhanga o ngā taiāwhio kāwana-ā-rohe, ā-motu atu hoki; ā
- Kua puta kē hei kaihautū ki roto ake i o rātou hapori.

#### Ko te hātepe mō te whai i ngā hunga tono e rua mō ngā Matāwaka

**Kia oti i ngā hunga tono te puka tapatanga me ngā kōere tāpiri ā, kia tae i mua atu i te 5pm o te 7 o Whiringa-ā-nuku 2022.
